- Lifeguard, Instruct, and perform maintenance tasks as required
- Prevent injuries by providing public education, enforcing safety rules and regulations, and responding appropriately in the event of an emergency
- Ensure that aquatics center is clean and safe by completing required maintenance tasks
- Maintain a positive work attitude, creating a professional and positive image when dealing with the public
- Ability to organize, set priorities and complete multiple tasks, while being adaptable to last minute changes
- Provide exceptional customer service to team and patrons
- Attend mandatory training sessions throughout the year
- Assist with various other duties as assigned
- Must have reliable transportation

The successful candidate must be available to work varying morning, mid- day, evening and weekend shifts.
