
RFP, while greatly affected by the COVID-19 Pandemic in 2020, is excited to report an increase in course offerings and registrations in 2021.





#### Article II Section 7.2 – Discipline to be replaced by the following:

"Such charge must be filed with the Secretary/Treasurer who shall immediately acquaint the President with the nature of the allegation, giving all relevant details."

Rationale: amalgamation of the positions of Secretary and Treasurer into one position benefits the Association as the current workload within each position is minimal and can be managed in one Board position. Thus, the result provides the opportunity to add an additional stream representative (Client Services Representative) to meet an existing gap in our service delivery.

#### 2. Article III Section 1.1 – Officers is repealed:

"The Officers of this Association shall be the President, President-Elect, Secretary and Treasurer who shall be elected at the Annual General Meeting in accordance with these Bylaws. The Officers will comprise the Executive of the Association."

#### Article III Section 1.1 Officers to be replaced by the following:

"The Officers of this Association shall be the President, President-Elect, Secretary/Treasurer and Past President who shall be elected at the Annual General Meeting in accordance with these Bylaws. The Officers will comprise the Executive of the Association."

Rationale: to reflect the change from Secretary and Treasurer to one position of Secretary/Treasurer.

#### 3. Article III Section 2.1 – Directors is repealed:

"There shall be a Board of Directors which shall consist of:

- President
- President-Elect
- Secretary
- Treasurer
- Immediate Past President
- Education Representative
- Associate Representative
- Pool Representative
- Arena Representative
- Building Maintenance & Operations Representative
- Parks & Sports Fields Representative"

#### Article III Section 2.1 Directors to be replaced by the following:

"There shall be a Board of Directors which shall consist of:

- President
- President-Elect
- Secretary/Treasurer
- Immediate Past President
- Education Representative
- Associate Representative
- Aquatic Representative
- Arena Representative
- Building Maintenance & Operations Representative
- Parks & Sports Field Representative
- Client Services Representative"

Rationale: to align with previously proposed changes to Board positions:

- The Secretary and Treasurer positions are combined as per Article III Section 1.1
- The change from Pool Representative to Aquatic is a more common term in the recreation industry and encompasses multiple aquatic environments.
- The addition of the Client Services Representative provides the opportunity to add an additional stream representative to meet an existing gap in our service delivery.

#### 4. Article III Section 3.1 – Elections of Officers and Directors is repealed:

Article III Section 3.1 – Election of Officers and Directors is replaced by the following:

"The President-Elect, Secretary/Treasurer, Education Representative, Aquatic Representative, Arena Representative, Building Maintenance & Operations Representative, Parks & Sports Field Representative and the Client Services Representative shall be elected at the Annual General Meeting by a simple majority of the membership present and they shall hold office for a period of two (2) years or until a successor is duly elected or appointed, as provided for in these Bylaws. They will each carry one (1) vote only on the Board of Directors."

Rationale: to align with the previously proposed changes to Board positions.
