




With the advent of Policy and Procedure and the Lifecycle & Risk Management Course being held online as well as in person we saw an increase in students.

# Arena Stream Report

Time has flown by, and I have plenty to report! Over the past two years, I have remained committed to my mandate of engaging, educating, and advocating for our members while also being an active and positive contributor to the AARFP Board of Directors.

**Engaging with Members** - I've been working to keep our Arena Stream Facebook group active and valuable by sharing educational content, important AARFP updates, and the occasional post to make you smile. It's been a great way to connect with members, answer questions, and keep the conversation going.

**Industry Writing & Education** - Writing articles for Leisure Lines has been both challenging and rewarding. Over the past year, I've covered topics such as:

- Summer Maintenance A deep dive into the fundamentals
- Preparing for the Ice-Making Process
- Environmentally Friendly Ice Removal
- Summer Maintenance Planning Part 2

I'm always open to suggestions—if there's a topic you'd like covered, let me know!

Beyond writing, I've also contributed to education and awareness by leading a **Connect Session** on Key Factors in Developing an Ammonia Release Emergency Response Plan and co-facilitating a **Leadership Challenges** workshop with Edith Martin.

**Surveys & Industry Insights** - We launched a survey to investigate whether group arrival times were a significant issue for rinks. However, with limited responses, the data didn't support the anecdotal concerns we had heard. We may revisit this topic in the future.

Additionally, we plan to relaunch the **Arena Survey** conducted two years ago to analyze trends and track industry changes.

2024 Conference & Member Support - The 2024 AARFP Conference in Lethbridge was a fantastic opportunity for learning and networking. I presented on alternative uses for ice shavings instead of simply dumping them outside and moderated the Open Forum—though participation was light, likely because the rest of the conference had already answered many of the members' questions!

Beyond events, I've enjoyed fielding member inquiries via email and social media on topics such as: •Personal Protective Equipment (PPE) and qualifications

- Temporary refrigeration systems
- Supplier recommendations
- Operational budget planning
